Admission *information*

The YMCA of Hong Kong Christian College (YHKCC) welcomes applications from students with a wide range of backgrounds. This enriches our international community and offers vital preparation for students to join today's world. The teacher student ratio is 1:8.5.

The school uses English as the medium of instruction (EMI). Only Chinese-related subjects are taught in Chinese. The average class sizes are shown in the table below:

LEVEL	CLASS SIZE
Form 1 to Form 4	About 24-29
Form 5 to Form 6 (HKDSE & GCE)	About 17-26

Most subjects, however, are taught in smaller groups of about 20 students because classes are divided into sets.

The school does **not** participate in the HKSAR Government's Form 1 or Form 4 Secondary School Place Allocation (SSPA) System. The school admits students directly. After applicants have been interviewed, **confirmed places may be offered**.

All new students in Forms 1-3 are required to bring a MacBook for lessons.

Second and Third Language

All students are required to study Chinese from Form 1 to Form 6 as a second language. The school-based Chinese Programme caters for the needs of students with different Chinese language learning backgrounds. The aim of this programme is to help students to gradually master the Chinese language skills needed for their future lives and for higher education, as well as developing a deep appreciation of Chinese culture.

Please refer to the School-Based Chinese Programme Information Sheet for more details.

All new students in Forms 1-2 are required to study Spanish *or* French as a third language.



Application *process*

1 To apply for a place in the YHKCC please complete the following documents:

- Application Form (Appendix III).
- Signed Enrollment Agreement (Appendix V).

NB. The YMCA of Hong Kong Christian College requires an **Academic Reference** (Appendix IV) and **Confirmation of Second Language Learning Background** (Appendix VI) for all applicants.

2 Enclose **photocopies** of all of the following documents:

- School reports for the past two years (i.e. Primary 4 and Primary 5).
- Applicant's HKID card or passport (including those pages with valid entry permit and personal particulars).
- Awards or certificates for extra-curricular activities and special achievements.
- Principal's recommendation letter, if any; and
- For non-local residents: Father's or Mother's passport (including those pages with valid working permit and personal particulars). Applicants must have the right of abode in Hong Kong.

3 Payment of the non-refundable application fee of HKD100 by bank transfer. (NB. The YHKCC does not accept cash or cheques.) Please attach the bank-in slip to the application form.

Assessment Process

Only shortlisted applicants will be arranged for interviews. Students applying for a place in Form 2 or above are also required to take tests in English and Mathematics. The admission criteria and the weightings for Form 1 applicants are as follows:

- Academic results during the last two years (weighting 35%).
- Interview performance (weighting 35%).
- Conduct or other comments from previous school(s) (weighting 20%).
- Participation in extra-curricular activities and social events, including any public examinations and awards, if any (weighting 10%).
- Individual interview with the Principal and/or Primary School visit by the Principal.

Students applying for admission to Forms 2 – 6 are required to meet the expected standard in all admission entry tests.

The result of the application is usually released within one month of the interview. To accept the offer, a non-refundable and non-transferable **registration fee** must be paid. The registration fee will be offset against the school fee for September 2022. Parents of successful Form 1 applicants will be asked to sign an undertaking declaring that their child will not participate in the Secondary School Place Allocation System.

Prior to making an application to join the school, parents of applicants are required to agree with all the terms and conditions stated in these Application Notes and the Enrollment Agreement. School places are only given to students and parents who are able to perform the following:

Students must join all school activities and camps, e.g. Pre-Form 1 Enhancement Course (if required), pre-Form 1 Summer Bridging Course (Monday 8th to Friday 19th August, 2022), Assemblies, Life-wide learning Camps, Service trips, etc. (NB. Newly enrolled students will be required to take tests in English, Mathematics and Chinese in mid-March 2022 and, if necessary, attend a Pre-Form 1 Enhancement Course on Saturday mornings from April 2022 to June 2022.)

Students must respect and participate in Christian activities.

Students must wear the prescribed school uniform. Any modifications to the school uniform, including additions or subtractions that may draw attention to faith-based differences, are not permitted.

Parents must pay school fees via Direct Debit. The school reserves the right to deregister the student if the school fee is not paid on time and the student will be asked to withdraw.

All personal information provided will only be used for admission related purposes and will be treated in strict confidence. Documents will not be returned to applicants. The personal information of unsuccessful applicants will be destroyed after one year.



School Fees *policy*

The YHKCC aims to provide an all round international style education at an affordable fee for students from Hong Kong and all over the world. The YHKCC is operated under the Direct Subsidy Scheme (DSS) and receives a subvention from the Education Bureau (EDB). The school also collects fees from parents. The subvention and school fees received from the EDB and parents respectively are used to fund a diverse range of quality educational programmes and provide excellent facilities.

Since the YHKCC is a non-profit making organization, the fee structure is determined according to the school's needs. Parents are consulted before making changes to existing school fees and the proposed changes are approved by the School Management Committee (SMC) and the EDB.

The income received by the school is used to pay staff salaries, purchase teaching and learning materials, fund student activities, maintain school facilities, and pay for utilities and other operating expenses. Any financial surplus at the end of each academic year is reinvested into the school by upgrading facilities and equipment.

Main Features of the School Fees Policy

- No Debenture or Capital Levy will be collected.
- The school fee for Form 1 students will remain unchanged for 2 years (i.e. Forms 1 to 2).
- The school fee for Form 3 students will remain unchanged for 2 years (i.e. Forms 3 to 4).
- The school fee for Form 5 (HKDSE and GCE) students will remain unchanged for 2 years (i.e. Forms 5 to 6).
- An upward school fee revision should be expected when promoting from Form 2 to Form 3 and from Form 4 to Form 5. According to past experience this increase is usually about 6-9%.
- School fees for the next academic year are usually published in October of the previous school year.
- School fees are collected by installments:-
Form 1 to Form 5 DSE & GCE: Ten installments from September to June; and
Form 6 DSE & GCE: Five installments from September to January.
- School fees are collected via Direct Debit.
- Non-local students are defined as those who require a student visa to study in Hong Kong. According to EDB policy, non-local students are not eligible for the government subsidy. Non-local students are required to pay a differential fee, which is composed of the regular school fee and an additional fee equal to the amount of government subsidy. The exact amount is subject to the EDB's announcement. Please contact the school for more information.

Payment of School Fees

A. Payment Methods

Since the collection of school fees is one of the main sources of income for the school and such funds are needed to support daily operating costs, parents are expected to be responsible and ensure that school fees are paid in a timely manner.

School fees must be paid via Direct Debit between the fifth and the tenth day of each calendar month from a designated local bank account.

The Direct Debit Authorization Form must be submitted to the school at the time the student is officially registered. The form can be downloaded from the school website or collected from the General Office.

B. Late Payment of School Fees

If the school fee is not paid on time, a reminder will be issued by phone or E-mail and a letter will be written to the parents concerned. If the school fee is overdue for more than 30 days, the school will have no choice but to consider terminating the school place and offering it to an applicant on the waiting list. If financial support is needed, parents are strongly encouraged to contact the school as soon as possible.



Fee Remission

The School Fee Remission Scheme, as operated and funded by the YHKCC, is intended to provide financial assistance on school fees for families with financial difficulties. Applicants should be parents/legal guardians of students registered and studying in the YHKCC. As a secondary school under the Direct Subsidy Scheme, the YHKCC follows the guidelines of the Education Bureau.

- At least 10% of the school's total school fee income is set aside to provide fee remission/scholarships for deserving students.
- If a DSS school charges a school fee between $\frac{2}{3}$ (two-thirds) and $2\frac{1}{3}$ (two and one-third) of the DSS unit subsidy rate, the school sets aside 50 cents for the fee remission/scholarship scheme for every additional dollar charged over and above $\frac{2}{3}$ (two-thirds) of the DSS unit subsidy rate.
- For all new applicants from 2017 / 2018, the maximum level of subsidy is 80% and 40% for the Full Fee Remission and Half Fee Remission respectively, subject to the availability of funds and the number of applications.

Thus, the actual amount of subsidy available for applicants is subject to the availability of funds. The amount of subsidy may be adjusted without prior notice.

Eligibility Criteria

Applicants must be eligible for one of the following categories:

Category 1: SFO

Households which are eligible for Financial Assistance for Primary and Secondary Students provided by the Student Financial Office (SFO)

(For the student-applicants who are Hong Kong Residents, residing with the family of applicants, with the right of abode, right to land or valid permission to remain without any condition of stay (other than the limit of stay in Hong Kong.)

Category 2: CSSA

Households which are currently recipients of the related Comprehensive Social Security Allowance (CSSA)

Category 3: Means test

Households passing the YHKCC means test

(For students holding visitor visas, two-way exit permits, student visas or who are dependents of non-local students / student-visa / visitor-visa holders). (For special situations, please seek advice from the Fee Remission Coordinator.)

All households applying for the Fee Remission Scheme, except for recipients of the CSSA, are required to apply through the SFO, which is conducted by the Hong Kong Government. Successful applicants of the SFO are also entitled to different financial support from the Hong Kong Government, including Transport Subsidy, Textbook Assistance and Internet Access Charges Subsidy, etc. Recipients of the CSSA or SFO are exempted from the means test conducted by the YHKCC.





Choice of Language Learning

Students in Forms 1 and 2 learn three languages: English Language, Chinese Language and either French or Spanish as a third language. When students are promoted to Form 3, they continue to study English and Chinese, and can choose to study French or Spanish as an elective subject.

English Language

English is the medium of instruction and is used for daily communication in the YHKCC community. The English Language curriculum consists of developing literacy skills and enhancing English Language competence through the appreciation of multi-modal texts and literature. It aims to enable students to be proficient in English and critically appreciate the beauty of all literature written in English.

Chinese Language

The Chinese Language curriculum provides students with a variety of learning opportunities to develop their Chinese literacy and appreciate Chinese literature and culture. The curriculum caters for students at different levels of Chinese proficiency.

- *Native Chinese speakers study the local Chinese Language curriculum and learn the traditional Chinese characters in Putonghua and/or Cantonese.
- #Non-Chinese Speaking Students (NCS) study the non-local Chinese Language curriculum and learn the simplified Chinese Characters in Putonghua. This tailor-made curriculum aims to help students catch up with the local Chinese Language curriculum.

From 2020 – 2021 onwards, all Form 1 students are required to study Chinese Language. Students are streamed according to their Chinese learning background. In addition to the Education Bureau's specific requirements regarding learning Chinese, an internal test is used to ensure that students are placed in the most suitable curriculum and receive the support they need from their teachers. As part of the admissions process, parents are required to submit relevant documents to prove their child's Chinese learning background.

Remarks:

*The local Chinese Language curriculum will be offered to

- students who studied the local Chinese language curriculum in primary school for 6 years, and
- the primary language spoken at home is Chinese.

#The non-local Chinese Language curriculum will be offered to

- students who studied elementary level Chinese in primary school (including local schools with an adapted Chinese curriculum, international schools in Hong Kong and schools overseas), or
- students who studied the local Chinese language curriculum in primary schools in Hong Kong for less than 6 years, or
- students with no foundation in Chinese language learning, and
- the primary language spoken at home is not Chinese





Third Language – French or Spanish

Besides English and Chinese, students are given an opportunity to learn a third language in Forms 1 and 2. The school offers a choice between French and Spanish. Both languages are widely spoken around the world and provide ample opportunities for students to explore and appreciate Western culture. Students who have a relevant language background or proficiency in their preferred third language may also be assessed. Once the third language has been confirmed by the school, **no** changes will be made.

New Students in Forms 3 and 4 in 2021 – 2022

Newly admitted students in Forms 3 and 4 in the 2021 – 2022 academic year are only required to take two languages. All students take English and either Chinese, French or Spanish. In general, students are expected to continue with the language they studied in their previous school. Parents are required to submit relevant documents to prove their child's Chinese learning background and the curriculum they are taking. Once the choice of second language has been confirmed by the school, **no** changes will be made.





Frequently *asked questions*

Q1

HOW OLD IS THE SCHOOL?

The school was founded by the YMCA of Hong Kong in September 2003.

Q2

WHERE IS YOUR SCHOOL LOCATED?

The school is located in Tung Chung (near the Mun Tung Estate). There are public transport services from Tung Chung MTR station to the school (Lantau Bus No.37, 38X & 39M). The school is currently providing bus services from Tsuen Wan & Tsing Yi, Tuen Mun & Sham Tseng, Prince Edward & Kowloon Tong, Whampao Garden & Elements, Tin Shui Wai & Yuen Long and Tung Chung. The services provided will be changed every year depending on the demand and the supply by the service providers.

Q3

WHAT ARE YOUR SCHOOL HOURS?

Students have lessons from 8:10 a.m. to 4:00 p.m. on Monday to Friday. All students are expected to be in school by 8:05 a.m. Extra lessons are sometimes scheduled after school and on Saturday mornings.

Q4

IS THE SCHOOL AN INTERNATIONAL SCHOOL?

The school is a Direct Subsidy Scheme (DSS) secondary school with English as the medium of instruction (EMI). The YHKCC is not an international school as such, but does provide an international style education. Over 70% of the students are international students.

In Form 3 students follow an integrated curriculum, which combines the content of both the Hong Kong curriculum (HKDSE) and IGCSE curriculum. Students can then apply to continue with the Hong Kong curriculum leading to the Hong Kong Diploma of Secondary Education (HKDSE) or complete their IGCSEs and study GCE Advanced Levels.

Q5

WHERE DO STUDENTS GO TO UNIVERSITY?

In the past few years YHKCC graduates have been admitted into all of the top universities in Hong Kong, including The University of Hong Kong, The Chinese University of Hong Kong, The Hong Kong University of Science and Technology, The Hong Kong Polytechnic University, The Hong Kong Baptist University, The Hong Kong Institute of Education, and the Hong Kong Shue Yan University. At the present time most of the students go to university in Hong Kong, but a few go to university in the UK, USA and Australia. The proportion of students applying to universities overseas is gradually increasing.

Q6

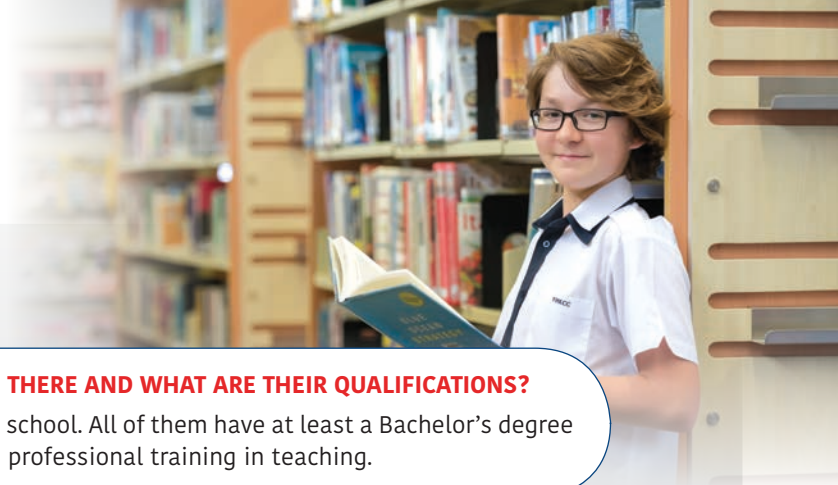
HOW MANY STUDENTS ARE THERE IN EACH CLASS?

There are about 21-30 students in each class. For English, Mathematics and Languages, students are taught in smaller groups of about 20 students per set. For elective subjects, there are usually fewer than 25 students in each set/group.

Q7

MY CHILD DOES NOT KNOW CHINESE – IS THIS A PROBLEM?

No, it is not a problem. Non-Chinese speaking students follow a tailor-made Chinese Language curriculum created for those who have very little or no background in the Chinese Language.

**Q8****HOW MANY TEACHERS ARE THERE AND WHAT ARE THEIR QUALIFICATIONS?**

There are 93 teachers in the school. All of them have at least a Bachelor's degree with more than 95% having professional training in teaching.

Q9**CAN MY CHILD APPLY TO JOIN ANY FORM?**

New students usually join the school in Form 1, but there are limited places in other year groups and all applications will be considered. Students joining Form 1 are usually 11 or 12 years old.

Q10**CAN WE VISIT THE SCHOOL?**

Q11**WHAT IS THE DEADLINE FOR APPLICATIONS? IS THERE AN INTERVIEW FOR MY CHILD?**

Applicants need to complete the application form and submit all relevant documents to the school. If the applicant meets the assessment criteria, an interview will be arranged for the student and her/his parents. A letter regarding the interview date and time will be sent to parents. Form 1 Admission interviews are usually scheduled in November and January while Form 2 or above admissions interviews are usually scheduled in May and June, depending on the number of places left after each round. The application deadline for each round of admission interview is usually three weeks prior to the interview date, and will be announced on the school website.

Q12**WHEN WILL I KNOW WHETHER MY CHILD WILL BE ACCEPTED AFTER THE INTERVIEW?**

The results will be released to parents within one month of the date of the interview. A letter regarding the admission result will be sent to parents. Applicants need to pay a non-refundable deposit to accept the offer. The deposit will be deducted from the school fee of September. Please note that students with a student visa need to pay an additional differential fee in addition to the proposed school fee.

Q13**DOES MY CHILD NEED TO HAVE VISA BEFORE I SUBMIT THE APPLICATION?**

No, this is not necessary. The application, together with all other required documents, can be submitted before the visa has been obtained. A copy of the visa should be sent to the school when it has been issued by the Hong Kong government. However, please note that a valid student or dependant visa must be in place prior to enrollment.

Q14**WHAT ARE THE ADMISSION CRITERIA?**

The admission criteria are as follows: interview performance, academic results for the past two years, conduct, extracurricular activities (such as music, performing arts, etc.), experiences in social services and any additional awards or achievements that the applicant may have.

Application Fee

An application fee of HKD\$100 must be paid when applying for a place in the YMCA of Hong Kong Christian College.

School Fees

Students holding a dependent visa are also classified as 'Local Students'.

² Non-local Students

'Non-local Students' are defined as those who require a student visa to study in Hong Kong. According to EDB policy, non-local students are not eligible for the government subsidy. Non-local students are required to pay a differential fee, which is composed of the regular school fee and an additional fee equal to the amount of government subsidy. (NB. The figures shown in the table above are for the current year. The differential fees for all forms will be adjusted upwards once the EDB announces the exact amount of the subsidy in due course.)

The school fee for Form 1 students will remain unchanged for 2 years (i.e. Forms 1 and 2).

The school fee will be adjusted upwards by approximately 6% – 9% in Form 3 and then again in Form 5.

Other Fees

An Advance Payment of \$3,000 is collected every year to cover miscellaneous fees, including the Student Handbook, Life-wide Learning Camp Fee, Enrichment Week and the cost of student activities incurred during the school year. When a student graduates or withdraws from the school, the remaining amount will be refunded to parents.

The Advance Payment is collected when students register for the next school year. This payment is usually collected in June.

Please note that the part of the Advance Payment is used to cover the cost of activities during Enrichment Week in July. There are lower cost options available during this week, but it is unlikely, however, to be sufficient to cover the cost of overseas trips or activities. Students usually need to pay between HKD500 and HKD6,000 for trips and activities, depending on the destination.

Payment Methods

School fees must be paid via Direct Debit between the fifth and the tenth day of each calendar month from the parents' designated local bank account. A message containing the date of bank transfer will be sent to parents' registered E-mail address at the beginning of each month.

School Fee Remission

ALTERNATIVE TRACK FOR FORM 1 ADMISSION – TALENTED SCHEME

ADMISSION PROCEDURES FOR FORM 1 ENTRY (2022 – 2023)

The YHKCC has a special admission procedure for students who are talented in specific areas.

Category 1: Applicants with a Strong Academic Background

Applicants who have excellent performance in English, Chinese and Mathematics (i.e. A/90 marks or above) and a conduct grade (or comments about the student's conduct) of B+/good or better on the Primary 5 report card will be granted an interview with the Principal directly.

Successful applicants may be awarded a full scholarship for the first two years of study (i.e. Form 1 and Form 2) in the YHKCC. The decision will be made at the discretion of the school. If the student on the scholarship scheme achieves a top five ranking on the second semester report card in Form 2, a full scholarship will also be granted for the following school year.

Category 2: Applicants with Additional Talents (e.g. Sport, Music, Visual Arts, Performing Arts)

Every school year the YHKCC sets aside some places for students who are talented in specific areas. It is expected that all applicants admitted to the school through this scheme will continue to actively participate in whichever area it is that they have special talents, e.g. excellent football players would join the school's football team.

Applicants satisfying the criteria listed below and the admission interview and assessment will be considered for special admission to the YHKCC.

Sport (Basketball, Badminton, Football, Rugby, Swimming)

- Active member of primary school club sports team(s).
- Outstanding achievement (i.e. top 3 place) in inter-school competitions.
- Recommendation letter(s) from sports federation/coaches of affiliated teams/clubs.
- Member of Hong Kong Team is **advantageous**.

Please supply evidence of individual or team awards, e.g. certificates, etc. An assessment by sports team teachers/coaches may be required.

Music

- Active member of primary school choir/orchestra/band.
- Outstanding qualifications in musical instruments (i.e. Grade 7 or higher).
- Outstanding achievement in inter-school competitions.
- Intention to join one of the music ECAs at YHKCC, e.g. choir, orchestra, worship band or percussion group.

Please supply evidence of individual or team awards, e.g. certificates, etc. An assessment by the music teacher may be required.

Visual Arts

- Outstanding achievement in inter-school competitions is **advantageous**.
- Practical demonstration of artistic talent.

Attendance at an interview with art teachers will be required.

- Portfolio of artwork and evidence of awards (e.g. certificates) should be brought to the interview. (NB. The portfolio of artwork should contain at least 10 pieces of drawing, painting and/ or 3D making skills. The portfolio may also contain examples of photography, printing and mixed media or collage work.)

Performing Arts - Drama

- Outstanding achievement in inter-school competitions.
- Outstanding performance in drama/play.

Please supply evidence of individual or team awards, e.g. certificates, etc. An assessment/interview by drama teachers may be required.

Performing Arts – Cheerleading

- **Standing** Gymnastic Skills (not limited to handsprings and tucks).
- **Dance** (30 seconds or 8 sets of 8 counts choreography in your choice of any of the following styles: ballet, jazz, hip-hop, contemporary, or cheer dance).

Please supply evidence of individual or team awards, e.g. certificates, etc. An assessment/interview by drama teachers may be required.

Performing Arts – Dance

- More than 3 years of external competition and/or performance experience, including both in-school and outside productions with consistently good results.
- Candidates should be able to complete a dance with no obvious errors, and dance with focus and confidence consistently matching body movements with the beat, and reflecting the beat/rhythm in the whole body.
- Demonstrate a keen sense of time and rhythm in performance and show an advanced ability to communicate ideas and feelings through movement.

General Notes

All applicants in this category must also satisfy the school's minimum academic and behavioural expectations, including a conduct grade (or comments about the student's conduct) of B+/good or better on the Primary 5 report card.

Shortlisted applicants with outstanding talents in sports, music, visual arts and/or performing arts can be recommended by the Principal and teachers from the primary school.

Successful applicants will be required to take internal academic assessments in English, Chinese and Mathematics. If the student's performance in these assessments is not up to the school's required standard, s/he must attend an after school academic support programme to enhance their standard and can only join one extra-curricular activity in sports, music, visual arts or performing arts.

Successful applicants may be granted a full or a partial scholarship for two school years. The decision will be made at the discretion of the school. Since the YMCA of Hong Kong Christian College (YHKCC) receives a DSS subsidy from the government, the school is bound by certain EDB regulations. The school is only permitted to offer an International Stream (GCE Advanced Level) in Forms 5 and 6 on the condition that students predominantly follow the local HKDSE curriculum. Places in the International Stream are therefore limited to a maximum of 80 students or at most 49% of the number of students in the cohort. I understand that even though my child is admitted to the school, this does not guarantee that s/he will be able to study in the International Stream. Acceptance in the International Stream depends on a combination of factors, including effort grades, academic performance in Forms 3 and 4, school reports, teacher recommendations and an interview.

Non-local children holding a student visa are not eligible to receive the government subsidy according to the EDB policy. These students will have to pay the differential full fee.

I understand that the school will try to allocate students to subjects according to their preference, but the final decision will be based on the students' academic performance at that time and the availability of places in their preferred subjects.

I will take full responsibility in ensuring that my child attends online lessons (if required) punctually and according to the school timetable. I understand that there are occasions when it may be necessary for my child to attend additional classes after school and/or during school holidays, and I consent to this.

I agree to pay reasonably for any damage to school property caused by my child's behaviour or misbehaviour at school, whether deliberately or unintentionally.

I agree that my child must join all school activities and camps (e.g. pre-Form 1 Enhancement Course (if required), pre-Form 1 Summer Bridging Course, Assemblies, Life-wide learning Camps, Service trips, etc.) and pay her/his school fees through Direct Debit directly from my bank account. I understand that the school has the right to adjust fees upon EDB approval and terminate my child's school place if I do not pay the fees on time. I also understand that the School Fee Remission Scheme, operated and funded by the YMCA of Hong Kong Christian College, is intended to help provide financial assistance for payment of school fees for students with financial difficulties. (NB. The amount of the subsidy approved depends on the amount of funding available in a particular year and that it is subject to approval by the school.)
